

UNIFORM LAW LABELS

LAW LABELS FOR BEDDING & FURNITURE

SIZE: The minimum size of the label shall not be less than 2 inches by 3 inches, but may be larger as need demands.

PRINTING: All printing shall be in the English language, color of the print shall be black on a white label. The minimum type size 1/8" inch in height or not less than 9 point type in capital letters for the "UNDER PENALTY OF LAW" Section and the "All NEW MATERIAL" section. The label material shall be Tyvek, Valeron, Vellum cloth or a material of comparable quality, which shall not flake out when abraded. There shall be no printing on the back of the law label.

DESCRIPTION: The description of the filling materials shall be it's true generic name, grade, or definitions as accepted and approved by the states. When more than one kind of filling material is used, the percent by weight of each shall be listed in order of their predominance.

NOTE: Some states require that the name of the manufacturer, importer, distributor or vendor be listed on the label. This information may be listed several different ways. For example: MADE BY.... (List the manufacturer) MADE FOR..... (List the Importer or Dist.) SOLD BY.... (List the Retailer)

OTHER INFORMATION: The "Other Information" section at the bottom of the label is where all federal requirements and any additional information shall be listed:

- **Date of delivery** _____ (Some states require this on the label. The manufacturer does not have to list a date on the line).
- **Finished size and/or weight of filling.** (Some states require this on the label for mattresses, foundations, futons, mattress pads, sleeping bag, sleeping pads, bed pillows, bedspreads, comforters, and similar articles. Size should be stated in inches.
- **Federal RN number** (This is a voluntary number issued by the Federal Trade Commission. This number is optional and does not have to be listed on your label.)
- ***MADE IN.....** (This is a U.S. Customs requirement)

**PLEASE NOTE: If a product is made in the U.S., either in whole or in part of imported materials the law label shall disclose these facts:*

EXAMPLE: "Made in U.S.A. of Imported Materials"

If a product is partially manufactured in a foreign country or some components are manufactured in a foreign country and then finished in the U.S. the law label shall disclose this information:

EXAMPLE: "Made in China, Finished in U.S.A." or "Shell Made in China, Filled and Finished in the U.S.A."

LAW LABELS FOR BEDDING & FURNITURE

No advertising or company logo is permitted on the law label. The label shall be securely affixed to the article in a location which is clearly visible to the consumer.

These labels are EXAMPLES ONLY, please contact the states in which you are going to sell your products before printing labels.

If you need to place a barcode on the label it must be at the bottom of the label separated by a bold black line from the rest of the information.

IMPORTANT NOTICE

In 1998 IABFLO approved the removal of the blank stamp block from the law label. In order to maintain a uniform law label the old style label (shown below) should be phased out by January 1st, 2005. After that date IABFLO will not approved the use of this law label.

FLAMMABILITY NOTICE

IABFLO approved that the California Flammability Warning, TB 116, TB 117 (for upholstered furniture) may be printed on the same label. The location can be side-by-side separated by a thick black line. The law label should be on the left and the warning notice on the right. The notice may also be printed at the bottom of the law label, separated by a thick black line.

The minimum size of the type for the flammability notice shall be 1/8 inch in height or 9 point. All type shall be in capital letters.

CALIFORNIA AND IABFLO APPROVED TB 603 LAW LABEL

TB 603 goes into effect on January 1st, 2005. The new TB 603 notice can ONLY go at the BOTTOM of the law label. TB 603 only applies to mattresses, box springs, foundations and futons manufactured after Jan. 1st, 2005.

TB 603 does not apply to "Top of Bed Items" such as pillows, comforters, quilted coverlets, quilt duvet or quilt shams.

California is in the process of testing these items and could issue TB 604 that would require these items to meet a flammability standard some time in the future.

NOTE: The TB 603 statement will NOT be required by the California Bureau of Home Furnishings after July, 1st 2007. The Consumer Product Safety Commission will begin enforcing 16 CFR 1633 on mattresses imported on or after July 1st, 2007.
